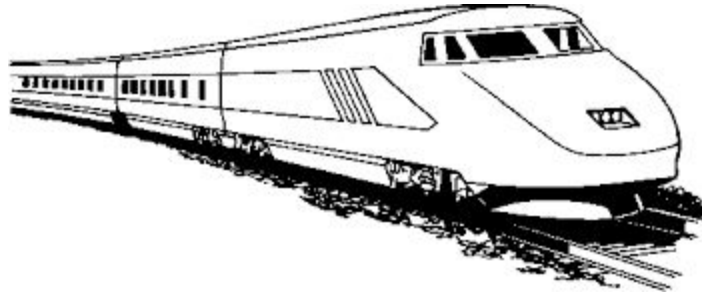

Electricity: There is no charge for electricity, however some shows are limited. Dealers must secure any cords to the floor using duct tape. Electricity should not be used ONLY for cell phone charging.

Merchandise: ALL non-train items must be approved prior to show date! We reserve the right to deny any merchandise at the show without prior notification.

Parking: We do not charge for parking, however Jamil Temple does charge for parking. We do not receive any proceeds. Please let the attendants know you are a 'dealer' and you will not be charged.

Payment: All tables must be paid in advance! We do not accept table requests without payment. Vendor payments are non-refundable and can not be transferred to a future show. No subletting tables allowed. All helpers must be in the facility by 8:45am or they will be required to pay admission.

*By purchasing tables, YOU AGREE to stay for the entire length of the show (3pm) and park in the designated vendor area. Failure to stay for the entire show may result in the inability to reserve tables in the future. **CTS and the operating facility are not responsible for any loss or damage to exhibitor's property.**
